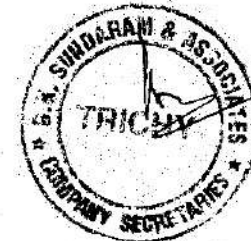

**REPORT OF SCRUTINIZER**

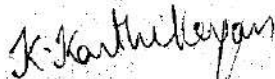

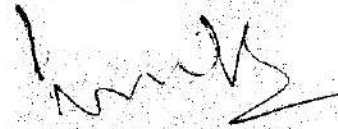
